Ph.D Admissions (2015-16) under Visvesvaraya Ph.D Scheme

1. General Instructions:

The Department of Electronics & Information Technology (DeitY) Ministry of Communication & Information Technology, Govt of India has sanctioned 5 (Five) Full-time and 5 (Five) Part-time Ph.D fellowships from the academic year 2015-16.

- 2. Eligibility Criteria: The candidates should have passed
 - 2.1. For ECE: BE/B.Tech (ECE)/AMITE/IETE and ME/M.Tech (ECE)
 - 2.2. For CSE:ME/M.Tech (CSE)
 - 2.3. Obtained a Post Graduate Degree from a recognized University securing not less than 55% marks for General Category candidates and securing not less than 50% marks in the case of SC/ST candidates.

3. Financial Support/ Scholarships:

3.1 For Full -Time Ph.D Candidates:

Fellowship @ Rs.22, 500 per month in 1st and 2nd year, and @ Rs.25, 000 per month in 3rd, 4th, 5th years of Ph.D programme.

Annual Contingency Grant/Support: @ Rs.30,000/- per year per full time Ph.D candidate for consumables etc. **Reimbursement of Rent (RoR):** For full-time Ph.D candidates who are not provided accommodation or choose not to avail the accommodation provided by the Institution, the RoR would be on reimbursement basis, based on actual and subjects to a ceiling based on location of the Institution registering the Ph.D candidate. The ceiling would be 30%, 20% and 10% of the fellowship amount as per the Government of India norms for class X, Y or Z cities respectively.

Support for attending International Conferences: Support for attending up to two renowned International Conferences for full – time Ph.D candidate, @ up to maximum support of Rs.50,000/- for each International Conference would be provided. The total support under the scheme is for 1000 such participations fulfilling the norms defined in the scheme on first come first serve basis.

3.2 Part – time Ph.D Candidates:

Part – time candidates who do not avail of a Ph.D Fellowship/Scholarship/Stipend from any Central or State Government shall be provided a onetime incentive of Rs. 2.5 lakh on successful completion of the Ph.D degree. The candidate/ Scholar WILL NOT BE ALLOWED to CHANGE the full-time or part-time till the completion of the Ph.D programme.

4. Admission Process:

- 4.1. Applications are invited from Candidates having the qualification defined under clause (2) sated above.
- 4.2. The Candidates should have obtained his admission for Master's programme on the basis of GATE Score

- 4.3. If more number of applications are received, a screening test will be conducted for short listing the candidates for the interview. The Institution/ University reserves its right to decide on the conduct of screening test and short listing of candidates.
- 4.4. Shortlisted candidates will have to appear for an interview along with his/her Research Proposal.
- 4.5. Final admission of candidates to Ph.D programme will be done as per Seat Matrix given in Annexure-I

5. Application Form and its Submission:

- 5.2 Filled in Application Form along with a DD for Rs 500/-(Rs 250/- In case of SC/ST) drawn in favour of the Principal, University College of Engineering(A), Osmania University payable at Hyderabad along with supporting documents as per Annexure –II is to be submitted in Principal's Office on or before 20th January 2016 at 4.00pm.
- 5.3 If applications are sent by post, the envelop is to be superscribed as "Application form for Admission to Ph.D. Program in Department of CSE/ECE under VS".
- **6.** Candidates from Industry /Research Organization are encouraged to apply.
- 7. Screening test if required will be held on 24th January 2016 at the Main Building UCE OU.
- **8.** Interviews for shortlisted candidates will be held in the second week of February 2016.
- **9.** All the information regarding admission process, Schedule of Screening Test, Shortlisted Candidates Names and Interview Scheduled etc will be updated on college Website.
- 10. The Syllabus for Screening Test (if conducted) for ECE and CSE is given in Annexure-III&IV respectively.
- 11. It is every candidate's personal responsibility to visit the Website and update himself / herself about the details stated in clause (9) above. No personal intimation / information will be sent to the candidates about Screening Test and Interview.
- 12. Short listing for Screening Test / Interview does not guarantee admission to Ph.D programme.
- 13. Candidates already admitted to Ph.D programme of Osmania University are not eligible to convert themselves to scholars under Visvesvsraya Ph.D Scheme.
